For what purpose do we treat your personal data?

In SPANJECAMPER, S.L we treat the information provided by interested persons to make the services offered by us available to third parties and for questions, reservations, requests and requests for the requested services, as well as sending commercial actions related to our products and services, for which you have given your consent.

How long do we keep your data?

The data is kept for as long as the commercial relationship is maintained, and if necessary for the years required to comply with the legal obligations arising from the application.

What is the legitimacy for the treatment of your data?

The legal basis for the treatment of your data concerns:
Performance of a contract: provision of requested services
Interested party's consent: transmission of commercial communications.

To which recipients will your data be communicated?

Your data is only transferred to comply with legal obligations.

Transfer of data to third countries

No data transfers are planned to third countries.

What are your rights when you provide us with your data?

Everyone has the right to receive confirmation as to whether SPANJECAMPER, S.L processes personal data that concerns the interested party or not. Interested persons have the right to access their personal data, as well as request rectification of inaccurate data or, where appropriate, request deletion when, for other reasons, the data is no longer needed for the purposes for which it was collected. In certain circumstances, interested parties may request that the processing of their data be limited, in which case we will only keep it for the exercise or defense of claims.

In certain circumstances and for reasons related to their specific situation, interested parties may object to the processing of their data. In this case, Spanjecamper, s.l. will stop processing the data, except for compelling legitimate reasons or the exercise or defense of possible claims. You can exercise your rights in the following way: by sending to an email address to the person responsible for the processing described above and attaching a copy of your ID or ID. If you have given your consent to the processing of your data for a specific purpose, you have the right to withdraw the consent given at any time, without affecting the legality of the treatment based on the consent prior to the withdrawal. In case you believe that your rights have been violated with regard to the protection of your personal data, in particular if you are not satisfied with the exercise of your rights, you can file a claim with the competent data protection authority via the website: www.agpd.es.
